REPAIRS INCLUDED: 292 FURNACE REPAIR/REPLACEMENTS, 171 ROOF REPAIRS, 106 WATER HEATERS, 67 NEW TOILETS INSTALLED, 460 PLUMBING CALLS, & 94 ELECTRICAL CALLS. THE TEAM ALSO CONSTRUCTED 29 WHEELCHAIR ACCESS RAMPS AND MODIFIED 32 BATHROOMS FOR HOMEOWNERS WITH REDUCED MOBILITY DUE TO PHYSICAL DISABILITIES.
